I agree to: (1) The loan principal and interest will be repaid through regular payroll deductions as long as there is a loan balance in my account; (2) by signing the Truth-in-Lending Disclosure Statement, I agree to the full terms and conditions of the Promissory Note; (3) if the terms and conditions of the loan are not acceptable to me, I will return the full loan amount and all documentation to ASC Trust Corporation, and the money will be returned to my account; (4) loan prepayment, in part or in full, is permitted at any time; (5) any unpaid balance may become due on the day my employment ends and may be taxable if not repaid at that time; (6) the loan will be funded through withdrawals from my eligible retirement accounts, divided proportionately among my investment funds; (7) my loan payment will be reinvested according to my fund selections at the time the payment is received; (8) a one-time loan setup fee of \$100.00; (9) a quarterly loan maintenance fee of \$15.00 will be charged prorata to my retirement account.
